## LEWIS & CLARK NRD MINUTES

March 17, 2022

Chair Heine called the March 17, 2022, meeting of the Lewis and Clark Natural Resources District (LCNRD) Board of Directors to order at 1:30 p.m. in the conference room at the LCNRD office. Chair Heine stated to the public present that prior notice of the meeting had been publicized according to policy designated by the board. Chair Heine announced that a copy of the Open Meetings Act is located on the west wall of the meeting room. Roll call of members. Present: Armstrong, Condon, Christensen, Heine, Howey, Johnson, Kramer, Schmidt, Steffen, and Weinandt. Absent: Hoesing.

## **CONSENT AGENDA**

Consent agenda review. It was moved by Kramer, seconded by Christensen to approve minutes of the February 17, 2022, board meeting and the February 18, 2022, to March 17, 2022, consent agenda. The consent agenda includes financial reports, cost share approvals, claims, corrections, and additions. (Copy attached to file copy of minutes). Chair Heine welcomed Thad Kuntz with Longitude 103, who presented on their NRD App for tracking resources, digitizing annual reports, and tracking and transmitting acre certification.

# **AGENCY ACTIVITIES**

Chair Heine welcomed Matt Moser, USGS Physical Scientist, who provided an update on the Bazile Nitrate stream gage.

Planning Committee: Johnson reviewed materials discussed at the planning committee meeting.

It was moved by Howey, seconded by Steffen to approve an agreement with USGS for a continuous nitrate gage on Bazile Creek for the 2022 ice out season, cost for LCNRD is \$13,000. Roll call vote: AYE: Armstrong, Christensen, Condon, Heine, Howey, Johnson, Kramer, Schmidt, Steffen, and Weinandt. NAY: None. ABSENT: Hoesing. Motion carried (10-0-1).

It was moved by Kramer, seconded by Schmidt to enter an agreement with Longitude 103 for the NRD App to track resources, digitize annual reports, track acre certification, and other resources with a one-time data transfer fee of \$14,000 with up to \$10,000 to be paid by the Nebraska Department of Natural Resources, a one-time fee to digitize water quality annual reports and transfer related data at a cost not to exceed \$7,500, and a recurring annual fee for the NRD App of \$14,000. Roll call vote: AYE: Armstrong, Christensen, Condon, Heine, Howey, Johnson, Kramer, Schmidt, Steffen and Weinandt. NAY; None. ABSENT: Hoesing. Motion carried (10-0-1).

NARD Activity: Kramer reported on NARD recent activities.

Natural Resources Commission (NRC): Steffen reported on recent NRC activities.

NE Nebraska RC&D and Wau-Col Rural Water Activities: No RC&D report. Howey reported on Wau-Col Rural Water activities from the March 3, 2022 meeting.

NRCS Report: Rebekah Jessen, NRCS District Conservationist reviewed current NRCS activities. Holly Gregg reported on the Program Assistants activities for the last quarter.

Bazile GWMA Updates: Reports from Whitney Gappa, Bazile Coordinator and Jeremy Milander, Bazile Extension Educator were provided in the packet.

Nebraska Forest Service: Chris Wood introduced himself to the board and reported on recent Forest Service activities. A written report from Pam Bergstrom was provided to the directors in the packet.

Rural Water Advisory Committee: The committee recommended establishing a checking account dedicated to the CKRWP expansion project and to establish a line of credit. At this time a resolution to establish a

checking account is considered and the line of credit will be postponed until clarification on interest rates is received.

Weinandt moved and Steffen seconded the following resolution:

<u>WHEREAS</u>, the Lewis and Clark Natural Resources District Board of Directors has determined it to be in the best interest of the Lewis and Clark Natural Resources District to extend a banking resolution with an FDIC Lending Institution, be it

<u>RESOLVED</u>, that the Lewis and Clark Natural Resources District grants the authority to establish a checking account for making payments related to the Cedar Knox Rural Water Project planned expansion expenses to the manager of the Lewis and Clark Natural Resources District.
