Natural Resources Commission (NRC): Steffen reported on NRC activities.

NARD Activity: Kramer reported on NARD activities.

Wau-Col Activities. Heine & Sudbeck were unable to attend the meeting, but Sudbeck gave a brief report from the minutes of the meeting.

RC&D Activities: No report.

NRCS Report: Rebekah Poppe, District Conservationist, reviewed NRCS activities and a written report provided.

Bazile GMA Updates: Lisa Lauver, Bazile Groundwater Management Area Coordinator reported on BGMA activities, and a report was included in the director packet. Jeremy Milander, UNL Bazile Extension Educator, provided a report included in the director packet.

Rural Water Advisory Committee: Weinandt and Fiedler reported on CKRWP activities and presented recommendations from the April 13, 2023; meeting of the Cedar Knox Rural Water Project Advisory Committee as follows:

- <u>To approve minutes of the March 9, 2023, Cedar Knox Rural Water Project Meeting.</u>
- <u>To approve expenses from March 10, 2023, to April 12, 2023, as presented.</u>
- <u>To allow all customers the option to choose either the 5<sup>th</sup> or the 15<sup>th</sup> for water payment to be</u> withdrawn from their bank account, current accounts set up for bank withdrawal will stay with the 5<sup>th</sup> unless they request the date change.

- <u>To approve the Water Service Connection for Terry Zavadil (Sec 35 T33N R1W in Cedar County) for</u> <u>1 Benefit Unit and to allow him to transfer an additional Benefit Unit from his other water service</u> <u>connection.</u>
- <u>To approve the \$1,000 Easement Water Service Connection for Dale Jansen (Sec 24 T33N R1W in</u> <u>Cedar County) for 1 BU.</u>
- <u>To approve the Water Service Connections for Riverside Bay LLC (Sec T33N R2W in Knox County)</u> for up to 42 Water Service Connections or 42 Benefit Units.
- <u>To have management enter an agreement with Bartlett & West to update the 2021 PER with current</u> price estimates for the 5 water source options, at the per hour rate not to exceed \$5,000.
- <u>To approve the consensus of the committee to work with Bartlett & West and LRE on an hourly basis,</u> as needed for assistance with information and education needs.

It was moved by Kollars, seconded by Steffen to approve the Cedar Knox Rural Water Project report and each recommendation as stated above. Roll call vote: AYE: Armstrong, Christensen, Condon, Heine, Johnson, Kollars, Kramer, Schmidt, Steffen, and Weinandt. NAY: None. ABSENT: Hoesing. Motion carried (10-0-1).

# WATER RESOURCES COMMITTEE:

Schmidt reported on and presented recommendations of the water resources committee, *it was moved by Kramer, seconded by Kollars to approve the Water Resources Committee report and the recommendation stated below.* 

- 1. Irrigated acre permits listed below:
  - a. <u>Valieda Burns replacement well permit LC-403R for a well in the NENW Section 19, T29N,</u> <u>R1W and flow meter cost share FMLC-403R.</u>
  - b. <u>*H & V Mueller LLC expanded acres permit X- 23015 for 200 acres in the E1/2NW, NWNW,*</u> <u>*E1/2SW, and SWSE Section 3, T29N, R4E.*</u>
  - *c.* Joseph Wuebben expanded acres permit X-23016 for 19 acres in the SESE Section 6, T32N, <u>R2E.</u>
  - *d.* <u>Ronald Mattes Life Estate expanded acres permit X-23017 for 15 acres in the NWSW Section</u> <u>14, T28N, R4E.</u>
  - e. <u>Fredrick & Diane Pick Trustees expanded acres permit X-23018 for 17 acres in the NWNW</u> <u>Section 34, T31N, R1E with the following conditions:</u>
    - *i.* <u>Allow nitrate testing from existing wells to be carried out by the LCNRD on a yearly basis.</u>
    - *ii.* The use of chemigation, multiple application periods and not to exceed recommended rates of nitrogen application is strongly encouraged.
    - iii. <u>Additional conservation may be required if nitrate levels show an increasing trend.</u>
  - *f.* Christopher & Michaela Jessen expanded acres permit X-23019 for 133 acres in the SW Section 10, T32N, R4W.
- 2. <u>Approve a grace period extension until the May 19 meeting for expired permits during the 180 day</u> stay, so they can either get the well drilled or apply for a new permit.
