CONSENT AGENDA

FY 2020 BUDGET

Manager Sudbeck reviewed the FY2020 budget and noted the total tax requirement will be 984,784.34. Chair Steffen reviewed Resolution 9A-2019. <u>It was moved by Hoesing seconded by Kramer to approve the FY2020 budget as presented and resolution # 9A-2019:</u>

WHEREAS, the Board of Directors of the Lewis and Clark Natural Resources District held a public hearing to hear and consider comments concerning the Fiscal Year 2020 Budget for the Cedar Knox Rural Water Project and the Lewis and Clark Natural Resources District on September 19, 2019.

NOW THEREFORE, the governing body of the Lewis and Clark Natural Resources District resolves that the attached budget document incorporated herein by reference, showing total requirements of \$3,331,719 and a tax requirement of \$984,784.34 is hereby adopted and set as the Fiscal Year 2020 budget of the Lewis and Clark Natural Resources District in accordance with \$77-1601-02.. Roll call vote: AYE: Armstrong, Christensen, Condon, Hoesing, Kramer, Steffen, Schmidt, Weinandt. NAY: None. ABSENT: Heine, Howey, Johnson. Motion carried 8-0-3).

Chair Steffen reviewed Resolution 9-19and <u>it was moved by Schmidt, seconded by Christensen to approve</u> <u>RESOLUTION NO: 9-19</u>

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Governing Body of the Lewis and Clark Natural Resources Districts passes by a majority vote a resolution or ordinance setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request.

NOW, THEREFORE, the Governing Board of the Lewis and Clark Natural Resources Districts resolves that:

- 1. The 2019-2020 property tax request be set at \$984,784.34
- 2. The total assessed value of property differs from last years' total assessed value by 0%
- 3. <u>The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be \$.024084 per \$100 of assessed value</u>
- 4. The Lewis and Clark Natural Resources District proposed to adopt a property tax request that will cause its tax rate to be \$.024673 per \$100 of assessed value
- 5. <u>Based on the proposed property tax request and changes in other revenue, the total operating budget of Lewis and Clark Natural Resources District will exceed last years by 2%</u>
- 6. A copy of this resolution be certified and forward to the County Clerk on or before October 13, 2019.

RURAL WATER REPORT

Weinandt reported on the recommendations made at by the Cedar Knox Rural Water Advisory Committee at the August and September meetings.

August 8, 2019 recommendations are:

- 1. Approve the minutes of the July 11, 2019 rural water meeting
- 2. Approve the expenses from July 12, 2019 August 8, 2019 as presented.
- 3. Approve Omni Tech contract maintaining terms as the previous year including the rental rate of \$1,200/year.
- 4. Approve applying for Safety Grant funds through the State of Nebraska DHHS to move and replace the electrical panels in the intake building.
- 5. Approve the Engineering Review Application for Gary Hoebelheinrich (Sec 31, T33N, R1E, Cedar County) for 1 BU.

September 12, 2019 recommendations are:

- 1. Approve the minutes of the August 8, 2019 Cedar Knox Rural Water Project meeting.
- 2. Approve the expenses from August 9, 2019 September 12, 2019 as presented.
- 3. Recommend the final Cedar Knox Rural Water Project Fiscal Year 2020 Budget to the Lewis and Clark Natural Resources District Board of Directors.
- 4. Approve Engineering Review Applications for Brent Arens (Sec 14, T33N, R1W, Whitetail Ridge Lots 1 & 2, Knox County) for 1 BU, Joe Merchant (Sec 15 T33N R2W, Merchant Valley Lot 3, Knox County) for 1 BU, Larry Heine (Sec 18 T33N R1E, Cedar County) for 1 BU.

Weinandt also reported on leaks, repairs, and ongoing groundwater source investigation. <u>It was moved by Armstrong, seconded by Schmidt to approve the rural water report and each of the recommendations as stated above. DIRECTORS ACTIVITY

In the absence of Gary Howey, Chair Steffen read the report for the Northeast Nebraska RC&D and Wau-Col Rural Water System. (copy of report attached to file copy of minutes)

Marcel Kramer reported on the 2 resolutions for the upcoming Nebraska Natural Resources District Annual Conference in Kearney on September 23 and 24.

Resolution #1 seeks changes in Nebraska statute to ensure all Nebraska Natural Resources Commission members be residents of the State of Nebraska. Consensus was 5 votes for the resolution.

Resolution #2 recommends changing Nebraska statute to enhance the financial authorities of all natural resources districts to provide authority to issue general obligation bonds to finance projects related to flood control, water quality projects, and water quantity projects for the public benefit of all Nebraskans and such amendment to Nebraska statutes should not be limited or constrained by any sunset provision. Consensus was 5 votes for the resolution.

These votes are dependent upon further discussion at the conference and the delegates have the authority to change votes if deemed necessary by LCNRD members in attendance at the conference.

Steffen reported on the recent Natural Resources Commission meeting including discussion on flooding and anticipated 2020 Water Sustainability Fund applications.

ADMINISTRATIVE ACTIVITY

Manager Sudbeck reported Bessey Nursery seedling prices for 2020 are increasing from \$0.75 to \$0.78 and board discussed changes to Lewis & Clark NRD rates. <u>It was moved by Hoesing, seconded by Kramer to approve FY 2020 tree rates at \$1.00 per seedling, \$0.90 per trees for planting with a minimum stop charge of \$250. Water Resources Coordinator Lammers reviewed one well permit application received from Kevin Becker. <u>It was moved by Armstrong</u>, seconded by Christensen to approve Well Permit LC-240 for Kevin Becker for an irrigation well in NESW Section 25, T33N-R1E, expanded acres permit X19013 for 69 acres located in S1/2 NESW, SESW, E1/2 SWSW Section 25, T33N, R1E and Flow meter cost share FMLC-240.
